### How To Register for Provider Training

Wyoming Medicaid providers are encouraged to register for provider training via the GoTo Webinar application as soon as possible.

To register, complete the following:

1. View the Provider Training Calendar.
2. Select the training you wish to register for and attend. The GoTo Webinar page opens in a browser window displaying the selected training, selection for dates and times available, and requested information required to complete registration.
3. Select the applicable date and time from the available options in the drop-down list.
4. Enter the provider's First Name, Last Name, and Email Address in the applicable fields.
5. Select **Register**.

Upon completion of the online registration, Providers receive a confirmation email from the GoTo Webinar application. The confirmation email contains key information, including:

- Date and time of the selected Provider training
- Join Webinar link – At the specified date and time, select this link to join the online Provider training
- A link to check your computer system to ensure there are no connection issues during the online webinar (this checks your Operating System [OS], web browser, and internet connection strength)
- Options for audio during the webinar (computer audio or telephone)
- Webinar ID Number
- Option to cancel registration for the online Provider training

New Provider Training	All Types	Overview of the Wyoming Medicaid website and Provider Portal, including key functions and tools providers use for billing, and account management.	1.5 hours
Institutional Inpatient TPL Submissions	Institutional Inpatient Providers (Excluding PRTF)	Guidance on submitting accurate Institutional Inpatient TPL claims, interpreting EOBs and adjustment codes, coordinating benefits, and avoiding common errors that lead to denials.	1.5 hours
Ambulance Billing Essentials	Ambulance Providers	Training on ambulance billing requirements, common denials and resolutions, and a high-level overview of WATRS and key resources.	1.5 hours
CME Billing Essentials	CME Providers	Training for Care Management Entity (CME) providers that covers billing requirements, common denials and resolutions, and key resources.	1.5 hours
